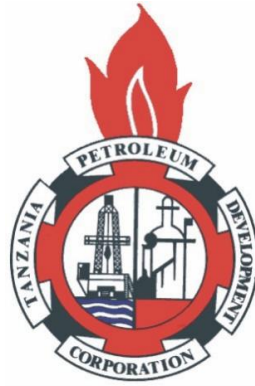

2. The Government of Tanzania has set aside funds for the operation of the Tanzania Petroleum development Corporation during the financial year 2016/2017. It is intended that part of the proceeds of the fund will be used to cover eligible payment under the contract for the Provision of Housekeeping Services.
3. The Tanzania Petroleum Development Corporation now invites sealed bids from eligible Service Providers for Provision of Housekeeping Services as specified below;
4. Tendering will be conducted through the National Competitive Tendering procedures specified in the Public Procurement Regulations, 2013 - Government Notice No. 446 and is open to all Tenderers as defined in the Regulations.

A complete set of Tendering Document(s) in English Language may be purchased by interested Tenderers upon submission of a written application to The Managing Director, Tanzania Petroleum Development Corporation, and P. O. Box 2774, Dar es Salaam upon payment of a non-refundable fee of Tsh 100,000 (Tanzanian Shilling One Hundred

Thousand Only). Payment should either be by Cash, Banker's Draft, or Banker's Cheque, payable to The Managing Director, Tanzania Petroleum Development Corporation, P. O. Box 2774, Dar es Salaam.

7. All tenders must be accompanied by a Tender Securing Declaration in the format provided in the Tendering Documents.
